

Home Security Rebate Scheme

The Town of Mosman Park is offering a Home Security Rebate to support residents in taking a proactive role in creating safer neighbourhoods. This rebate will help subsidise the cost of installing new home security devices. The following rebates are available under the scheme:

Security Item	Standard Rebate	Pensioners & Health Care Card holders Rebate
Home Intruder Alarm	\$200	\$250
Door Deadlock (per lock)	\$30	\$50
Keyed Window Lock (per lock)	\$25	\$30
Security Sensor Light	\$40	\$55
Security Screen Door (per door)	\$70	\$110
Security Window Screen (per window)	\$35	\$50
CCTV Security Camera	\$200	\$250

Application Process

- Forward a completed Home Security Rebate Scheme application and written quote or invoice from a licenced security agent to the Town of Mosman Park:
 - Mail – Town of Mosman Park, PO Box 3, Mosman Park WA 6912
 - Email – admin@mosmanpark.wa.gov.au
 - In person – Town of Mosman Park Administration Centre, Cnr memorial Drive & Bay View Terrace, Mosman Park between 8.30am and 4.30pm weekdays.
- Once approved, a signed copy with a voucher number returned to you.
- When work is complete return a copy of the invoice, the signed assessment, and voucher number to the Town of Mosman Park.
- For work already complete a voucher number will be issued once an invoice has been received and the application approved. Please note that in both cases no commitment for funding is made until a voucher number is returned to the applicant.
- Payment will be processed to your nominated bank account and may take up to three weeks.

Conditions

- A maximum of \$200 per application (or \$250 for Pensioner or Health Care Card holders) is payable under the scheme.
- Only one application per residence will be considered.
- Rebates may be available for work completed up to six months prior to the date of application.
- Security devices must be provided and installed by a registered business with a Security Agents Licence and sensor lights by a registered electrician.
- Property investors are eligible to claim a maximum rebate of \$200 through the scheme.
- The Town provides no guarantee that a home security rebate can be provided to eligible applicants. Approval is subject to available funding.
- Rebates must be claimed within two months of approval.
